Sailing Barge May: The Bread & Roses Barge CIC is a social enterprise which owns and manages the Thames Sailing Barge May.

We are passionate about creating a new modern, socially-committed future for May, with a clear community purpose. Our purpose is to create a community that can offer support and friendship to women who have suffered abuse, whether physical or emotional, histonc or recent. We offer community events such as craft and wellbeing sessions, but our aim is to install a bakery in the hold of May so both the community and groups of vulnerable women can share the experience of the gentle art of sourdough baking.

Once restored This vision is for May to become a regular visitor again to ports along her historic trading route on the east coast, where we will provide her as a facility and welcoming space, for groups and organisations working to improve the lives of women and their families.

In this, her first year as part of the CIC, she was moved to the St Osyth Boatyard where she is located in a safe and secure berth. Although in need of restoration, the hold remains warm and welcoming and has become a nurturing space to enable discussion, target wellbeing, isolation and companionship. A year of planning, gathering research and discovering what is possible, our aim to encourage community awareness and involvement has been achieved through arranging events such as coffee mornings, open events and a series of pilot events involving a growing number of community stakeholders and future stakeholders from organisations that support vulnerable women, such as Mind, the Next Chapter, Homestart.

There is a growing need for something a little different to inspire and make a difference within the community which we have established through conversations with stakeholders and

through feedback received from our Pilot Events.

Alongside this primary activity, we intend to provide May as a meeting and training facility for organisations promoting women in the maritime sector.
