Sailing Barge May: The Bread and Roses Barge CIC continues to be a social enterprise owning and managing the Thames Sailing Barge May

This year we have received grants from Essex Community Foundation; Essex County Council Active Essex; and Community Voluntary Services Tendring to enable partnership work with our community

Essex Community Foundation donated £4980 for us to hold 6 well-being days over the course of 3 months working with partnered organisations offering a free day onboard SB May. The day included refreshments, lunch and an activity facilitated by a specialist

The team members worked with each individual organisation to ascertain the best activity for the group, sourcing an appropriate facilitator for each session on a date suitable for all. Dietary needs and any mobility concerns for the clients were discussed

Next Chapter Women's Refuge had 2 sessions: the first was a yoga session with clients in a recovery phase from domestic abuse along with their support workers. The day was gentle, peaceful and created mindfulness for all that attended.

The second session for Next Chapter was a craft day applying collage, paint and pens to previously made women clay figures: these women were currently living in the Refuge and decorated their figures to reflect their own lives

Homestart Harwich mothers and their supporters attended an Embroidery/Sewing workshop using material, hoops, beads and threads. This workshop was chatty, excited and vibrant with many women sewing; some who had never done anything like this before

TeenTalk Harwich's young adults attended a clay session with the work then being fired and returned at a later date. Encouragement to each individual to create something pertinent to themselves created a quiet, contemplative, thoughtful and creative atmosphere

Carers from Carers First attended an colourful art and craft session using inks, pastels and oils whilst being guided to create 4 different individual works of art. The atmosphere was buzzing with enthusiasm, excited chatter and lots of colour.

MIND held a Mental Health Awareness workshop which the general public were invited to attend. The facilitator covered mental health self care leaving all attendees with the tools for good mental health awareness

In addition we were granted 3 months of core costs which helped us open SB May up to the general public.

Within this period we had various local Women's Institute groups coming aboard for afternoon tea and scones. Our Director gave several talks about the project to local community groups.

Community Voluntary Services Tendring awarded us £1000 for Cancer Screening

Awareness and we facilitated this by requesting everybody who stepped aboard to fill in an anonymous questionnaire regarding their Cancer Screening habits. Alongside were leaflets and discussions about cancer screening with information reported back to CVST.

Linking in to this, we held a Menopause Support Session Open Evening for women to come aboard to meet Julie Court - a Nutritionist who specialises in Menopause symptoms and treatments. Feedback was very positive.

Towards the end of this financial period our bid for funding from Essex County Council for the Active Essex project was successful. The award was used to cover the costs of planning and holding four 6 week courses of yoga onboard SB May.


We have had various donations which enabled us to open May up to the public. As a primary example, Clacton Womens Golf Club donated £3670.00

Hosting a Splicing Workshop organised by Women in Boatbuilding CIC (led by Jas from Heritage Marine Foundation) enabled women from all walks of life to come on board for a day to learn how to splice ropes

Also this year we have updated our website to improve navigation and better reflect our purpose and activities.

Finally we were awarded funds from Pin Mill Bay CIC who ceased trading, amounting to just over £10000. The late skipper of SB May Gerald Gadd was a founder member of the PMBCIC

We continue to care for the fabric of May ensuring the cover is as water tight as possible, keeping her pumped free of water and opened up to the public and organisations as much as possible. The community engagement summarised above proves that SBMay is a significantly valuable asset to the wider community. This is coupled with her incredible heritage. We are deeply passionate about saving her for future generations.

In response to social media posts, new volunteers have become involved. Their roles include, but are not limited to - helping with activities onboard, taking responsibility for sourcing grants, accounting and overseeing general organisation.

Feedback gathered through social media and questionnaires completed by those that have been aboard continues to be extremely enthusiastic. The positivity shared has been motivational. We are looking forward to further improvement with our Governance and have consulted with Erica Crump from Bates Wells Solicitors to share good practice. We are in the process of appointing volunteers to broaden the scope of this governance and the general running of the project.
