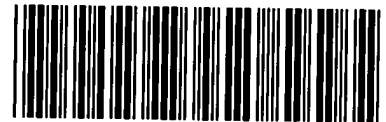

Every member of the company undertakes to contribute to the assets of the company, in the event of a winding up, such an amount as may be required not exceeding £1.

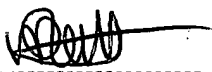
For the year ending 31 July 2023 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.

## **PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT**

**Surrey Missing Pet Support C.I.C. provides support to missing pet owners across the Surrey County, alongside providing support to members of the public who have found a straying pet. We also provide support to other organisations where possible, including local vets, volunteer groups and Surrey Police.**

**Support provided varies, based on individual animals and circumstances. It can range from missing poster printing, social media awareness, microchip scanning, food base monitoring and trapping using specialised equipment. We also offer after care support, including but not limited to supporting access to veterinary care, microchipping and neutering.**

**When supporting found and straying pets, we complete extensive searches for owners; this includes contacting microchip databases, physical and online missing posters, liaising with local vets and council/ dog collection services. We provide care and veterinary checks while searching; if no owner can be identified within a month we then vet and check potential applicant homes before placing in a permanent adoption. All animals that we have re-homed are fully health checked, vaccinated, microchipped and neutered. We liaise with other rehoming charities who have waiting lists of potential homes, to ensure an animal is placed in a secure permanent environment as soon as possible.**

**We have raised awareness of best ownership practices within local communities, holding activity days and microchip checking services. We promote best practice in pet care, including health and wellbeing advice, as well as responsible pet ownership through microchipping and neutering support. We have engaged with local Duke of Edinburgh students, helping them to complete their volunteering awards as well as fundraising through events. We have also closely supported the local charity Here For Cats with microchip checking services and accepting referrals from previous Here For Cats cats who have been missing.**

**We have raised awareness of new legislation being implemented in 2024 for the microchipping of cats, both online and during our activity days and when reuniting stray animals.**

**We have successfully reunited or re-homed 257 animals during the 2022-23 accounting period. We have provided 2845 missing and found posters to the members of the public, and have travelled approximately 1337.8 miles in our reunification and rehoming services.**

**The support model has been constructed based on the extensive and long term knowledge of the director in assisting with missing pets as part of a volunteer network. We take advice and suggestions from both owners and organisations; owners are encouraged to complete feedback when their pet has been found, as well as during the period their pet was missing. Volunteers regularly check in with owners via calls, texts or messages to make sure they feel they are receiving enough support. We also take into consideration suggestions from other organisations, we now ensure all straying unneutered cats are now routinely blood checked for illness following advice from supporting veterinary centres for example.**

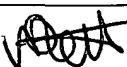
