The Socially Engaged Art Salon created this year 12 exhibition related to contemporary social and historical issues and showed the work of more than 80 artists. The exhibitions informed the general public about issues concerning minority groups such as BME, LGBTQ+ and artists with disabilities.

All the exhibitions took place in public spaces, i.e. community centres and the local library. The exhibitions were created for occasions such as Black History Month, LGBTQ History Month and refugee week.

The exhibitions were free and centred on artists' work from underrepresented sectors. The exhibitions we curated amplified the voice of communities and artists who are still marginalised from the art market and public art arena and thus do not benefit from what the arts can offer, including the mental and social benefits from engagement in creative work, contribution to social cohesion and wellbeing, fighting loneliness, increasing self-esteem and confidence and more.

In addition to the exhibition programme, SEAS delivered a series of public events, artists' talks and creative workshops at the Black and Minorites Ethnics Community Partnership Centre and the LGBTQ+ Ledward Centre. All these were offered free of charge.

SEAS also delivered an art therapy programme, two pieces of research commissioned by the local council concerning ethnic and sexual minorities in Brighton and hosted the Social Art Network UK assembly

We also had formal and informal discussions with the managers of the community centre and the library regarding our activities and the way to improve them.

The main feedback we received from the stakeholders were in regard to the need for longer time for planning and increase of outreach and publicity. As a result SEAS took a new team member who is responsible for these area including marketing and PR.
