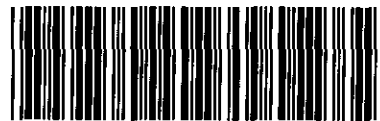

For the year ended 31 March 2023 the company was entitled to exemption under section 479a of the Companies Act 2006.


Directors' responsibilities:

General Information

BPUWL 17 Limited is a private company, limited by shares, registered in England and Wales, registration number 13547660, registration address Second Floor Hanover House, 47 Corn Street, Bristol, BS1 1HT.

The presentation currency is £ sterling.

1. Accounting policies

Significant accounting policies

These financial statements have been prepared in accordance with applicable United Kingdom accounting standards, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland' ('FRS 102'), and with the Companies Act 2006. The financial statements have been prepared on the historical cost basis.

Going concern basis

Accounting standards require the directors to consider the appropriateness of the going concern basis when preparing the financial statements. For the foreseeable future, the company will be solvent due to an intercompany loan agreement with the parent company, Belltown Power UK Wind Limited. The directors, therefore, consider the going concern basis appropriate.

Taxation

Tax is recognised in the statement of comprehensive income. The current income tax charge is calculated on the basis of tax rates and laws that have been enacted or substantively enacted by the balance sheet date in the countries where the company operates and generates income.

Intangible assets

Intangible assets consist of capitalised development costs once the project passes from the planning/investigative phase into the development phase.
