UPON THE APPLICATION by a Claim Form dated the 06 March 2023 of Hazel Winifred Curno, Deborah Clarke and Heather Wilson the Claimants and creditors of the above named LCJ Tamworth Ltd (hereinafter called "the Company")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of His Majesty to the relief sought by this Claim as appears from the waiver letter from the Treasury Solicitor dated the 12 June 2023

AND ON the leave of the Court being given to amend the Claim Form to reflect the correct name of the Company as LCJ Tamworth Ltd and re-service being dispensed with

AND the Claimants by their solicitors undertaking to:

- (A) immediately upon restoration of the name of the Company to the Register of Companies, present a Petition to the Court for the compulsory winding up of the Company
- (B) inform the Registrar of Companies of the title and Court reference number of the said Petition immediately after issue
- (C) inform the Registrar of Companies of the outcome of the hearing of the said Petition

(D) within 21 days of the making of any compulsory winding up Order in respect of the Company deliver an Office Copy of that Order to the Registrar of Companies

AND UPON the solicitors for the Claimants and for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named LCJ Tamworth Ltd be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 13598164 Ltd
- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"
- (5) the Claimants do jointly and severally pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300-00
- (6) the hearing fixed for the 13 July 2023 at 2:00 pm be vacated


