## **Company activities and impact**

We conducted a series of workshops for teens and elders in the Totnes area, which were very well received, and worked online in collaboration with Ecoversities and YouthxYouth, engaging participants from 8 different countries. You can read our June 2022 report here <https://tinyurl.com/mr4a62xrl> In the summer of 2022, we joined a collaboration with three other practitioners and began working on Tales to Live By - a community project in Plymouth focused on mental health and suicide prevention. Our contribution to this project is to hold space for intergenerational connection and storytelling.

## **Consultation with stakeholders**

We have been gathering feedback from workshop participants, directly after workshops and 2-3 months after to record any changes in attitude, outlook and behaviour. We meet semi-regularly with members of the local community to explore ways to improve our offering and adapt our programmes to meet their needs. We are developing connections with schools to start offering tailored workshops to secondary school pupils.
