

This valuable, creative insight has been able to improve the relationship with young people that others work with. Service development is necessary from live experience leaders to ensure that young people are equipped with the right tools to succeed.

Art remedy workshops have been delivered all around the UK, reaching as far as Glasgov supporting those living within disadvantaged groups by designing tailored, creative workshop and allowing a space for learning, healing and growth. Art has been proven to help those disadvantaged groups by providing an avenue for expression, a way to process emotions ar improve mental health.

Our focus has mainly been on care leavers. Within the next 2 years, the organization hopes have a helpline set up to enable appropriate signposting, a place where care leavers can capport. This helpline will provide a safe space for care leavers to talk and receive the necessary support they need. The organization believes that every care leaver deserves the opportunity to succeed and will continue to work towards providing the necessary tools achieve this.

Children of a revolution have been through a lot, but we have not let their trauma hold us bac In fact, they we have used our experiences to fuel creativity and inspire others. We have bee working closely with these individuals in a professional and personal nature to ensure the everyone has access to the arts, regardless of their background or circumstances.

One of the key areas we focus on is helping people understand the care system and the challenges faced by children in care. We believe that by raising awareness and providir support, we can help these children overcome their difficulties and thrive.

In addition to this, we also work with other disadvantaged groups to provide opportunities for expression and growth through the arts. We believe that everyone should have the chance explore their creativity and find their voice, no matter what obstacles they may face.

Through our work, we have seen firsthand the incredible impact that the arts can have c people's lives. They can help us heal, connect with others, and find hope and meaning in eve the darkest of times.
