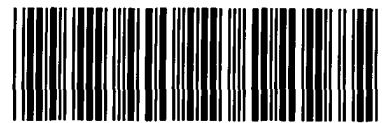

**1 Statutory information**

Some Yellow Ltd is a private company, limited by shares, registered in England and Wales, registration number 14016120. The registered office is 20 St. Pauls Rise, Addingham, Ilkley, West Yorkshire, LS29 0QD, England.

**2 Average number of employees**

During the period the average number of employees was 0.
