ORDER

UPON the application of the Claimant by way of a Part 8 Claim Form issued on 15 July 2022 ("**the Claim**") in respect of the companies listed in the Schedule to this Order (each such company being an "**Affected Company**" and, together, the "**Affected Companies**")

AND UPON reading the witness statement of Nadya Kathleen Kilgour dated 14 July 2022

AND UPON HEARING Mr Nigel Dougherty of Counsel for the Claimant

AND UPON the Defendant ("**the Registrar**") confirming by letter dated 14 July 2022 and email dated 21 July 2022 that the Registrar has no objection to the order being made on these terms

IT IS DECLARED THAT

1. For the purposes of section 1096(1) of the Companies Act 2006, that information (of the type identified in Paragraph 3 of this Order) given on the register maintained by the Registrar under section 1080 of the Companies Act 2006 ("**the Register**") in relation to each Affected Company is factually inaccurate, or derived from something factually inaccurate or is forged because the persons to whom such information relates (together the "**Affected Individuals**") do not, and have never had, any role or interest or involvement in the incorporation of such Affected Company as either director, shareholder, initial member, person with significant control, or otherwise.
2. For the purposes of section 1096(3) of the Companies Act 2006, so far as the information referred to in Paragraph 1 of this Order falls within the scope of section 1094 of the Companies Act 2006, the presence of that information on the Register has caused or may cause damage to the Affected Company and that the Affected Company's interest in the removing the material would outweigh any interest of other persons in such material continuing to appear on the Register.

AND IT IS ORDERED THAT

3. Following receipt of a sealed copy of this Order, the Registrar shall, pursuant to section 1096(1) of the Companies Act 2006 remove from the Register the following information in respect of each of the Affected Companies (to the extent that such information is or then remains included on the Register):
 - 3.1 In respect of the director of each Affected Company appointed upon incorporation of that Affected Company:
 - 3.1.1 Full name (forename(s), middle name(s) and surname);
 - 3.1.2 Date of birth (including where it appears as month/ year of birth only);
 - 3.1.3 Usual residential address;
 - 3.1.4 Correspondence address/service address;

- 3.1.5 Nationality; and
 - 3.1.6 Country/State usually resident/Country of residence
- 3.2 In respect of the initial shareholder of each Affected Company:
 - 3.2.1 Full name (forename(s), middle name(s), and surname);
and
 - 3.2.2 Address
- 3.3 In respect of the person with significant control of each Affected Company on incorporation:
 - 3.3.1 Full name (forename(s), middle name(s) and surname);
 - 3.3.2 Date of birth (including where it appears as month/ year of birth only);
 - 3.3.3 Usual residential address;
 - 3.3.4 Correspondence address/service address;
 - 3.3.5 Nationality; and
 - 3.3.6 Country/State usually resident/Country of residence
- 3.4 In respect of the subscriber of each Affected Company on incorporation (named as authoriser for the purposes of the Statement of Compliance listed in the Memorandum of Association):
 - 3.4.1 Full name (forename(s), middle name(s) and surname)

in each case, as contained in the application to incorporate each Affected Company (Form IN01) delivered to the Registrar and registered on the incorporation date in respect of the relevant Affected Company (as set out in the Schedule) and/or the Memorandum of Association of the same date in respect of the relevant Affected Company, whether such information has been made available for public inspection (pursuant to section 1085 of the Companies Act 2006) or not (by virtue of section 1087 of the Companies Act 2006).

- 4. The Claimants shall provide a copy of this Order to each of the Affected Individuals by email.

5. The Claimants may apply to restore the Claim and to amend the Claim (if needs be) for the purposes of seeking further or similar orders in respect of the Register and without the need to issue new proceedings. So far as may be practicable, any request by the Claimant to amend the Claim and for further or similar orders in respect of the Register shall be referred to ICC Judge Jones or Deputy ICC Judge Schaffer (if either is available) and may be dealt with on paper and without a further hearing.
6. There be no order as to costs.
7. This Order shall be served by the Claimant on the Registrar.
