#### Company activities and impact

We run funded programmes within a number of funding streams. In no particular order Active Coffee Morning PilotA 10 week programme funded but Active HW (Sports Partnership). Trialling the benefits of an exercise session combined with social activity (coffee morning) for cancer patients. Funding received for room hire, instructor and refreshments. Active Coffee MorningFollowing the successful pilot project Active HW continued their funding for a further 15 weeks and this was matched by Macmillan. Additional funding supplied for marketing and additional equipment so that numbers could be increased. WOW FCThe Worcestershire Oncology Walking Football Club. I helped to set up the sessions originally and continue to support with the social side organising a venue and refreshments for matches for example. Funding has now been received from Macmillan to assist with this and to buy some additional football shirts for new players to promote team wellbeing. Batter Breast CancerAn initiative to trial Boxercise sessions for Breast Cancer patients. Funding received from Active HW for room hire and equipment purchase.BadmintonFunding received to support junior badminton in Worcester. The funding originally came from Badminton England and was held by the University of Worcester Badminton Performance Centre. The centre has now closed so the remainder was transferred to Active Always Ltd for me to manage. I then transferred it to the CIC as it was easier to ringfence it for the specific badminton purpose. Used to provide a coach, provide equipment to a couple of local clubs and to set up and run the school games. Exercise is Medicine Funding received from Active HW to run a number of exercise sessions for social prescribers. This has been delayed a number of times due to conversations over requirements between Active HW and the PCN and then a lack of referrals from GPs. Active HW asked us to keep the money and to revert back to the original premise. We should be starting this month

#### Consultation with stakeholders

Our main stakeholders are Active HW, Macmillan, Worcestershire Breast Unit Haven, Kidderminster and Worcestershire Prostate Cancer Support Group, Worcestershire Oncology Centre, Freedom Leisure, Onside Advocacy and the participants of our programs. I am on the Cancer Services Network and I support Macmillan and the support groups by attending and presenting at their Living Well days. They refer patients onto our programmes. I also have regular meetings with representatives from Active HW.
