The most challenging enterprise of company in 2023 was taking part in a summer camp in Ukraine – Grapevine Youth Camp 2023. It was the camp for young people, mostly from Lvov area, it was 7 days long and we sent volunteers from England, Ireland, Poland and Romania. The camp focused on building relationships between people from different countries, teaching English, learning about other cultures, and of course having fun. Apart from being English teachers our volunteers shared their life stories and experiences, and provided all kind of assistance to the Ukrainian hosts.

The camp was the most challenging enterprise so far for our volunteers. The host organization (Josiah Venture) had tremendous difficulties with finding English teachers from abroad this year, due to the fact the camp was organized during the full scale war. One of the ambitions of To Be Happy C.I.C. is to go where nobody else dares. The value to international community (in this case Ukrainians) of our presence was invaluable.

It was Company's first year and we focused on organizing the team and procedures in the most effective way, considering the tiny budget. The tools we chose proved to be highly effective. It helped that we have several skilled IT experts in our team, including one of the directors.

We producing few podcasts in Polish. We produced episodes for long running podcast "Odwyk", a brand new "Dzień Kobiet" and "Samouczek". We started live show called "Izba Wytrzeźwień" on Wednesdays. In total, 70 episodes of podcasts have been produced this year.

We continued to run blog "Po Ludzku", also in Polish. 17 new blog articles have been added.

We started working on a new multilingual website, called "Backside of God". The project will be based on multilingual interactive narrative videos. The unique message for a listener is constant encouragement to look for more education and to find own personal answers in life and to make own personal choices. So far the project is in preparation stage.

In 2023 To Be Happy C.I.C. partnered with "Friends of Handicap in Rwanda", a charitable organization in Rwanda, East Africa. The "Friends of Handicap in Rwanda" cares for and educates young people with disabilities (mainly deaf and blind). We hold meetings to determine what projects we can run together. Being realistic, we cannot afford to hold big ambitions at this time, our tiny budget is the most limiting factor.

The other group of stakeholders are our volunteers and all those who have donated money to the company. We have been informing them by newsletters and Discord announcements about status of our current and new projects. All volunteers are encouraged to participate in our work by joining the management system on Trello or discuss matters on Discord.

With all the other stakeholders (for example kids at the camp we participated, listeners to our podcasts and shows) we talk personally as volunteers, whenever opportunity comes and time allows.
