

- **4. You** charge to **us** with full title guarantee as continuing security for the payment and discharge of all the **secured liabilities**:
 - 4.1 the property by way of legal mortgage, and
 - 4.2 the ancillary assets by way of fixed charge.
- 5. This mortgage deed secures further advances if we make them but we are not obliged to do so.
- 6. You consent to and apply for the registration of the following restriction against title to the property: "No disposition of the registered estate by the proprietor of the registered estate or by the proprietor of any registered charge, not being a charge registered before the entry of this registration is to be registered without written consent signed by the proprietor for the time being of the charge dated [30/06/33] in favour of Fleet Mortgages Limited referred to in the charges register".




