Terms

1. DEFINITIONS AND INTERPRETATION

This Deed shall be interpreted in accordance with paragraphs 1 (Definitions), 2 (Construction) and 3 (Third party rights) of Schedule 2 (Definitions and interpretation).

2. CREATION OF SECURITY

- 2.1. General
 - The Borrower shall pay or discharge the Secured Liabilities in the manner provided for in the Finance Documents. Ь.
 - All the security created under this Deed is: tiicreated in favour of the Lender;
 - created over present and future assets of the Borrower; an
 - (iii) security for the payment of all the Secured Liabilities; and
 - (iv) made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994.
- 2.2. Land

 - by way of legal mortgage all estates or interests in any Property now owned by it; this includes the real property (if any) (1)specified in Schedule 1 (Real Property);

The Borrower makes the representations and warranties set out in this Clause 3.

- It is a limited liability corporation, duly incorporated and validly existing under the law of its jurisdiction of incorporation.
- b. It and each of its Subsidiaries has the power to own its assets and carry on its business as it is being conducted.
- The obligations expressed to be assumed by it in each Pinance Document are legal, valid, binding and enforceable obligations. 3.2.

- 3.3. The entry into and performance by it of, and the transactions contemplated by, the Finance Documents do not and will not conflict with:
 - a. any law or regulation applicable to it:
 - b. its or any of its Subsidiaries' constitutional documents; or
- c. any agreement or instrument binding upon it or any of its Subsidiaries or any of its or any of its Subsidiaries' assets.
- 3.4. It has the power to enter into, perform and deliver, and has taken all necessary action to nuthorise its entry into, performance and delivery of, the Finance Documents to which it is a party and the transactions contemplated by those Finance Documents.

4. RESTRICTIONS ON DEALINGS

The Borrower shall not:

- 4.1. create or permit to subsist any Security over any Security Asset;
- 4.2. enter into any transaction to sell, lease, licence, transfer or otherwise dispose, or part with possession, of all or part of any Security Asset; or
- 4.3. accept a surrender of any lease or tenancy or confer upon any person any right to occupy a Charged Property, except with the prior written consent of the Lender.

5. LAND

5.1.

- The Borrower represents and warrants to the Lender that (except as disclosed to the Lender in writing before the date of this Deed):
 (i) no breach of any law, regulation or covenant is continuing which adversely affects the value, saleability or use of the Charged Property;
 - (ii) there is no covenant, agreement, stipulation, reservation, condition, interest, right, cosement, claim or other matter whatsoever adversely affecting the Charged Property;
 - (iii) nothing is outstanding which would be an overriding interest, or an unregistered interest which overrides first registration or registered dispositions, over the Charged Property; and
- registered dispositions, over the Charged Property; and (iv) all facilities necessary for the enjoyment and use of the Charged Property are enjoyed by the Charged Property.
- S.2. The Borrower shall:
 - exercise its rights and comply with its obligations under each lease comprised in, or covenants in respect of, the Charged Property in a proper and timely manner; and
 - b. not do or allow to be done any act as a result of which any lease comprised in the Charged Property may become liable to forfeiture or otherwise be terminated or any covenant in respect of the Charged Property be breached.
- 5.3. The Borrower shall ensure that all buildings, plant, machinery, fixtures and fittings on the Charged Property are maintained in good and substantial repair and condition and, as appropriate, good working order.

7. ENFORCEMENT OF SECURITY

- a. For the purposes of all powers implied by statute, the Secured Liabilities are deemed to have become due and payable on the date of this Deed.
- Section 103 of the Act (restricting the power of sale) and section 93 of the Act (restricting the right of consolidation) do not apply to þ. this Security.

- The Lender may by writing under its hand remove any Receiver appointed by it and may, whenever it thinks fit, appoint a new 8.2. Receiver in the place of any Receiver whose appointment may for any reason have terminated.

11.1. Power of Attorney

The Lender or any Receiver may, at any time, delegate by power of attorney or otherwise to any person for any period, all or any right, power, authority or discretion exercisable by it under this Deed.

Liability 11.2 Neither the Lender nor any Receiver shall be bound to supervise, or will be in any way responsible for any damages, costs or losses incurred by reason of any misconduct, omission or default on the part of any delegate or sub-delegate.

12. FURTHER ASSURANCES

- 12.1. The Borrower shall promptly, at its own expense, take whatever action the Lender or a Receiver may require for:
- creating, perfecting or protecting any security over any Security Asset; or
- facilitating the realisation of any Security Asset, or the exercise of any right, power or discretion exercisable, by the Lender or any h. Receiver or any of their respective delegates or sub-delegates in respect of any Security Asset.
- The action that may be required under paragraph (a) above includes (without limitation): 12.2.
- a. the execution of any mortgage, charge, transfer, conveyance, assignment or assurance in respect of any asset, whether to the Lender, its nominee or any other person; or
- the giving of any notice, order or direction and the making of any filing or registration, which, in any such case, the Lender may b. consider necessary or desirable.

POWER OF ATTORNEY 13.

The Borrower, by way of security, irrevocably and severally appoints the Lender, each Receiver and any of their respective delegates or sub-delegates to be its attorney with the full power and authority of the Borrower to execute, deliver and perfect all deeds, instruments and other documents in its name and otherwise on its behalf and to do or cause to be done all acts and things, in each case, which may be required or which any attorney may, in its absolute discretion, deem necessary for carrying out any obligation of the Borrower under or pursuant to this Deed or generally for enabling the Lender or any Receiver to exercise the respective powers conferred on them under this Deed or by law. The Borrower ratifies and confirms whatever any attorney does or purports to do under its appointment under this Clause 13.

14. PRESERVATION OF SECURITY

If any discharge, release or arrangement (whether in respect of the obligations of the Borrower or any security for those obligations or otherwise) is made by the Lender in which is avoided or must be restored in insolvency, liquidation, administration or otherwise, without limitation, the liability of the Borrower under this Deci will continue or be reinstated as if the discharge, release or arrangement had not occurred.

15. MISCELLANEOUS

15.1. Continuing Security

This Security is a continuing security and shall extend to the ultimate balance of the Secured Liabilities for the Security Period regardless of any intermediate payment or discharge in whole or in part.

- 15.2. Tacking

16. RELEASE

A notice sent by the Lender to the Borrower: (a) by post shall be deemed to be effective two Working Days after the date of posting (properly addressed and stamped); (b) by hand delivery, shall be deemed to be effective at the time of delivery; or (c) by email or text shall be deemed to be effective on the date of sending unless it is received after Spm (UK time), in which case it shall be deemed only to become effective on the next Working Day.

18. GOVERNING LAW AND JURISDICTION

- 18.1. This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law.
- 18.2. The courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed (including a dispute relating to the existence, validity or termination of this Deed or any non-contractual obligation arising out of or in connection with this Deed) (a Dispute).
- 18.3. The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no Party will argue to the contrary.
