Request to use 'University' in the business name "Trustees of Boston University"

Thank you for your email requesting a non-objection letter to the use of the sensitive word "university" in the above proposed business name.

We cannot comment on any necessary approval or non-objection to the word "trustees", which does not fall to this Department and on which we cannot offer legal advice. What follows does not give non-objection to the term "trustees", if needed.

Regulations brought into force under the Companies Act 2006 mean that the Department has responsibility for advice regarding consent to use the sensitive word 'University' in a business name. In the case of any organisation wishing to register a name which includes the word 'university' it is important that the title is clear, unambiguous and is not otherwise misleading.

With regard to your request to register the name "Trustees of Boston University", having considered the context of your request and the evidence you have provided from Boston University we are satisfied that the use of the word 'University' is appropriate in this context. I can confirm that DfE has no objection to the use of the term "University" in the business name "Trustees of Boston University".

You should now make a formal application to Companies House in order to seek approval of a Business Name under the Companies Act 2006. Companies House should be contacted via the following email address - enquiries@companieshouse.gov.uk.
