DIRECTORS' REPORT

Directors' Report for the 53 weeks ended 28 February 2009

The directors present their report and financial statements of Tesco Pink (1LP) Limited ("the company") for the 53 weeks ended 28 February 2009.

Business review and principal activities

The principal activity of the company is to act as an investment company.

The results for the 53 weeks show a pre-tax profit of £75,018 (2008:£nil) and sales of £nil (2008:£nil). The directors do not recommend the payment of a dividend (2008: £nil).

The company has net assets of £243,018 (2008: £168,000).

Future outlook

The company's level of trade is expected to continue throughout 2009 and it is hoped that the current performance levels will be maintained.

Principal risks and uncertainties

From the perspective of the company, the principal risks and uncertainties are integrated with the principal risks of Tesco PLC and are not managed separately. These risks are discussed on page 38 of the Tesco PLC group annual report for the 53 weeks ended 28 February 2009 which does not form part of this report.

- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business, in which case there will be supporting assumptions or qualifications as necessary.

The directors confirm that they have complied with the above requirements in preparing the financial statements.

The directors are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the United Kingdom Companies Acts 1985 and 2006 as applicable. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1 ACCOUNTING POLICIES

Basis of preparation of financial statements

The financial statements are prepared on the going concern basis in accordance with applicable United Kingdom accounting standards, under the historical cost convention, and in accordance with the Companies Act 1985. The company's principal account policies have been applied consistently during the period, and are set out below.

In accordance with FRS 2 "Accounting for Subsidiary Undertakings" and Section 228 of Companies Act 1985, group financial statements have not been prepared because the company is a wholly owned subsidiary of Tesco PLC, incorporated in England and Wales.

Cash flow statement

The company is a wholly owned subsidiary of Tesco PLC and is included in the consolidated financial statements of Tesco PLC, which are publicly available. Consequently, the company has taken advantage of the exemption from preparing a cash flow statement under terms FRS 1.

Taxation

The amount included in the Profit and Loss account is based on the profit or loss on ordinary activities before taxation and is calculated at current local tax rates, taking into account timing differences and the likelihood of realisation of deferred tax assets and liabilities. The company is also subject to tax on a share of the profits of the underlying partnership (The Tesco Pink Limited Partnership).

Group relief on taxation

The company will receive group relief from group companies without payment and consequently there may be no tax charge in the Profit and Loss account.

The company is also subject to tax on the profits of the underlying partnership (The Tesco Pink Limited Partnership).

2 OPERATING PROFIT

The directors received no emoluments in respect of their services to the company.

The company had no employees during the period (2008: none).

3 TAXATION ON PROFIT ON ORDINARY ACTIVITIES

Factors that have affected the tax charge

The standard rate of Corporation Tax in the UK was changed from 30% to 28% with effect from April 2008. This gives an overall blended Corporation Tax rate for the company for the full year of 28.2 %.

11 RELATED PARTY DISCLOSURES

Transactions with other companies within the group are not disclosed as the company has taken advantage of the exemption under paragraph 3(c) of Financial Reporting Standard 8 "Related Party Disclosures", as the consolidated financial statements of Tesco PLC in which the company is included, are available at the address noted above.

12 POST BALANCE SHEET EVENTS

On 30th March 2009, Philip Shirley retired as a limited partner of The Tesco Pink Limited Partnership and transferred his Partnership participation to Tesco Pink (1LP) Limited and Tesco Pink (2LP) Limited in equal proportions in consideration for £65,864.44 pursuant to the deed of retirement and assignment of Partnership participation. Upon his retirement, Philip Shirley would be released from any and all Partnership liabilities and obligations. It is noted that upon transfer of Philip Shirley's Partnership participation the Company's net share of the profits and losses of the Partnership would each increase by 0.05% to 49.95%.

On the 30th March 2009 Tesco Property Holdings Limited acquired a further 1,000 ordinary shares of £1 each in the Company at a premium of £64.90 per share, giving a total consideration of £65,900.
