

Directors' report for the year ended 31 December 2013

The Directors present their annual report and the audited financial statements of Bupa Malta Investments No 1 Limited ("the Company") for the year ended 31 December 2013

The Company is a limited liability Company and was incorporated on 15 November 2004 in Gibraltar, with its registered address at 9/3A International Commercial Centre, Casemates Square, Gibraltar On 17 December 2004, it was registered as an overseas company in Malta. The Company's management and control was transferred from Malta to the United Kingdom on 24 November 2006.

1. Principal activities

The principal activity of the Company until 2011 was that of an investment holding company During 2011, the Company began a series of transactions to reduce the capital of the Company The Company is now dormant

2 Business review

In 2013, the Company received a final £3,125,000 distribution of assets relating to its investment in Bupa Guernsey LLP (in liquidation). As a result of this distribution, the Company reversed a £3,125,000 write off made during 2011 in relation to this investment. During the year the Company has also reversed a write off made during 2011 in relation to amounts owed to Bupa Guernsey LLP of £3,125,000. There were no other transactions during the year.

No dividends were paid during the year (2012 nil)
