- At any Shareholders' meeting a resolution put to the vote of the meeting shall be decided on a show of hands, unless a poll is (before or on the declaration of the result of the show of hands) demanded by the chairman or one or more Shareholders present in person or by proxy entitled to vote, and unless a poll is so demanded, a declaration by the chairman that a resolution has, on a show of hands, been carried, or carried unanimously, or by a particular majority, or lost, and an entry to that effect in the book of the proceedings of the Company, shall be conclusive evidence of the fact, without proof of the number or proportion of the votes recorded in favour of, or against, that resolution

VOTES OF SHAREHOLDERS

- Subject to any rights and restrictions for the time being attached to any Share, on a show of 60 hands every Shareholder present in person and every Person representing a Shareholder by proxy shall, at a Shareholders' meeting, each have one vote and on a poll every Shareholder and every Person representing a Shareholder by proxy shall have one vote for each Share of which he or the Person represented by proxy is the holder

- No Shareholder shall be entitled to vote at any Shareholders' meeting unless all calls, if any, or other sums presently payable by him in respect of Shares carrying the right to vote held by him have been paid 63
- A Shareholder may be represented at a meeting of Shareholders by a proxy who may speak and 64. vote on behalf of the Shareholder
- The instrument appointing a proxy shall be in writing under the hand of the appointor or of his 65 attorney duly authorised in writing or, if the appointor is a corporation, either under Seal or under the hand of an officer or attorney duly authorised. A proxy need not be a Shareholder
- An instrument appointing a proxy may be in any usual or common form or such other form as the 66 Directors may approve

 - (a) by the Shareholders for such terms as the Shareholders may determine, or
 - (b) by the Directors for such terms as the Directors may determine

A person shall not be appointed as a Director unless he has consented in writing to be a Director

- 76 Each Director shall hold office for the term, if any, fixed by the Resolution of Shareholders or the Resolution of Directors, as the case may be, appointing him. In the case of a Director who is an individual the term of office of a Director shall terminate on the Director's death, resignation or The bankruptcy of a Director or the appointment of a liquidator, administrator or receiver of a corporate Director shall terminate the term of office of such Director
- 77 A Director may be removed from office, with or without cause, by a Resolution of Shareholders or, with cause, by a Resolution of Directors. A resolution passed under this Article may only be passed at a meeting called for the purpose of removing the Director or for purposes including the removal of the Director, or by written resolution passed by at least seventy five percent of the Shareholders, or Directors, as the case may be, entitled to vote
- 78 A Director may resign his office by giving written notice of his resignation to the Company and the resignation shall have effect from the date the notice is received by the Company or from such later date as may be specified in the notice
- A vacancy in the board of Directors arising as a result of the death of a Director or if a Director 79 otherwise ceases to hold office prior to the expiration of his stipulated term of office, may be filled
- The remuneration of the Directors may be determined by a Resolution of Directors or by a Resolution of Shareholders. 80
- Directors unless determined otherwise by a There shall be no shareholding qualification 81 Resolution of Shareholders
- 82 The Company shall keep a Reguster of Directors containing
 - the names and addresses of the persons who are Directors or who have been nominated (a) as reserve directors of the Company
 - whose name is entered in the Register of Directors was (b) the date on which each person appointed as a Director, of nominated as a reserve director, of the Company,
 - the date on which each person named as a Director ceased to be a Director, and (c)
 - the date on which the nomination of any person nominated as a reserve director ceased (d) to have effect

- 87 The Company shall not enter into any contract or commitment which commits the Company to an expenditure over the term of the contract or commitment in excess of GBP500,000 without any such contract or commitment being approved by a Resolution of Directors
- The Directors may, by a Resolution of Directors, appoint any Person, including a person who is a Director, to be an Officer or agent of the Company. The Resolution of Directors appointing an agent may authorise the agent to appoint one or more substitutes or delegates to exercise some or all of the powers conferred on the agent by the Company.
- Every Officer or agent of the Company has such powers and authority of the Directors, including the power and authority to affix the Seal, as are set forthein these Articles or in the Resolution of Directors appointing the Officer or agent texcept that no Officer or agent has any power or authority with respect to the matters requiring a Resolution of Directors under the Act or these Articles or are otherwise not permitted to be delegated under the Act
- Directors appointing the Officer or agent except that no Officer or agent has any power or authority with respect to the matters requiring a Resolution of Directors under the Act or these Articles or are otherwise including the delegated under the Act

 All cheques, promissory notes, drafts, bills of exchange and other negotiable instruments and all receipts for monies paid to the Company shall be signed, drawn, accepted, endorsed or otherwise executed, as the case may be by a minimum of two Directors or duly authorised officers of the Company and otherwise in such manner as shall from time to time be determined by Resolution of Directors
- All agreements, letters, notices, certificates, acknowledgements, receipts, authorisations, instructions, releases, waivers, proxies, appointment of agents for service of process and other documents shall be signed, drawn, accepted, endorsed or otherwise executed as the case may be by two Directors or duly authorised officers of the Company and otherwise in such manner as shall from time to time be determined by Resolution of Directors

- 99 A Director may participate in any meeting of the Directors, or of any committee appointed by the Directors of which such Director is a member, by means of telephone or other electronic means provided that all persons participating in such meeting can hear one other and such participation shall be deemed to constitute presence in person at the meeting
- 100 A Director shall be given not less than three days' notice of meetings of Directors, but a meeting of Directors held without three days' notice having been given to all Directors shall be valid if all the Directors entitled to vote at the meeting who do not attend, waive notice of the meeting, and for this purpose, the presence of a Director at the meeting shall be deemed to constitute waiver on his part. Any Director may act by himself or his firm in a professional capacity for the Company, and he or his firm shall be entitled to remuneration for professional services as if he were not a Director, provided that nothing herein contained shall authorise a Director or his firm to act as auditor to the Company
- 104 The Directors shall cause the following corporate records to be kept
 - (a) minutes of all meetings of Directors, Shareholders, committees of Directors, committees of Officers and committees of Shareholders, and
 - copies of all resolutions consented to by Directors, Shareholders, Classes of (b) Shareholders, committees of Directors, committees of Officers and committees of Shareholders

The consent may be in the form of counterparts, each counterpart being signed by one or more Directors.
- The continuing Directors may act notwithstanding any vacancy in their body but if and for so long as their number is reduced below the number fixed by or pursuant to these Articles as the necessary quorum of Directors, the continuing Directors may act for the purpose of increasing the number of Directors, or of summoning a Shareholders' meeting, but for no other purpose

CONFLICT OF INTERESTS

- 117 A Director shall forthwith after becoming aware of the fact that he is interested in a transaction entered into or to be entered into by the Company, disclose the interest to the board of Directors Where a Director's interest in a transaction is not disclosed in accordance with this Article prior to the transaction being entered into, unless it is not required to be disclosed in accordance with Article 119 below, the transaction is voidable by the Company
- 118 Notwithstanding the previous Article, a transaction entered into by the Company is not voidable by the Company if
 - the material facts of the interest of the Director in the transaction are known by the (a) Shareholders entitled to vote at a meeting of Shareholders and the transaction is approved or ratified by a Resolution of Shareholders, or
 - (b) the Company received fair value for the transaction, and such determination of fair value is made on the basis of the information known to the Company and the interested Director at the time that the transaction was entered into
- A Director is not required to comply with Atticle 14 7 above, if the transaction is between the Company and the Director and the transaction or proposed transaction is or is to be entered into in the ordinary course of the Company's business and on usual terms and conditions 119
- A Director who is interested in a transaction entered into or to be entered into by the Company 120 may
 - vote on a matter relating to the transaction (a)
 - attend a meeting of Directors at which the matter relating to the transaction arises and be (b) included among the Directors present at the meeting for the purpose of a quorum, and
 - sign a document on behalf of the company, or do any other thing in his capacity as a (c) Director, that relates to the transaction

REGISTER OF CHARGES

- 121 The Company shall maintain at the Registered Office or at the office of the Registered Agent a register of all charges created by the Company showing

- unless the charge is a security to bearer, the name and address of the holder of the (e) charge, and
- details of any prohibition or restriction, if any, contained in the instrument creating the **(f)** charge on the power of the Company to create any future charge ranking in prionty to or equally with the charge

THE SEAL

- 122 The Directors shall provide for the safe custody of the Seal. An imprint of the Seal shall be kept at the office of the Registered Agent

- 129 No Distribution shall bear interest as against the Company and no Distribution shall be authorised or made on Treasury Shares

ACCOUNTS AND AUDIT

- 133 The Company shall keep such accounts and records that
 - (a) are sufficient to show and explain the Company's transactions, and
 - (b) will at any time, enable the financial position of the Company to be determined with reasonable accuracy
- The books of account shall be kept at the officerof the Registered Agent or at such other place or places as the Directors think fit, and shall always be open to the inspection of the Directors
- The Directors may from time to time determine whether and to what extent and at what times and places and under what conditions or regulations the accounts and books of the Company or any of them shall be open to the inspection of Shareholders not being Directors, and no Shareholder (not being a Director) shall have any right of sinspecting any account or book or document of the Company except as conferred by law or authorised by a Resolution of Directors or by a Resolution of Shareholders
- The accounts relating to the Company's affairs shall only be audited if the Directors so determine, in which case the financial year end and the accounting principles will be determined by the Directors
- 137 The auditors of the Company shall not be deemed to be Officers

NOTICES

- Any notice or document may be served by the Company or by the Person entitled to give notice to any Shareholder either personally, or by posting it airmail or air courier service in a prepaid letter addressed to such Shareholder at his address as appearing in the Register of Members, or by electronic mail to any electronic mail address such Shareholder may have specified in writing for the purpose of such service of notices, or by facsimile should the Directors deem it appropriate. In the case of joint holders of a Share, all notices shall be given to that one of the joint holders whose name stands first in the Register of Members in respect of the joint holding, and notice so given shall be sufficient notice to all the joint holders.
- Any Shareholder present, either personally or by proxy, at any Shareholders' meeting shall for all purposes be deemed to have received due notice of such meeting and, where requisite, of the purposes for which such meeting was convened
- 140 Any notice or other document, if served by

- (a) post, shall be deemed to have been served five days after the time when the letter containing the same is posted,
- (b) facsimile, shall be deemed to have been served upon production by the transmitting facsimile machine of a report confirming transmission of the facsimile in full to the facsimile number of the recipient,
- (c) recognised courier service, shall be deemed to have been served 48 hours after the time when the letter containing the same is delivered to the courier service, or
- (d) electronic mail, shall be deemed to have been served immediately upon the time of the transmission by electronic mail

In proving service by post or courier service it shall be sufficient to prove that the letter containing the notice or documents was properly addressed and duly posted or delivered to the courier service

- Any notice or document delivered or sent by post to or left at the registered address of any Shareholder in accordance with the terms of these Articles shall notwithstanding that such Shareholder be then dead or bankrupt, and whether or not the Company has notice of his death or bankruptcy, be deemed to have been dilly served in respect of any Share registered in the name of such Shareholder as sole or joint holder, juriess his name shall at the time of the service of the notice or document, have been removed from the Flegister of Members as the holder of the Share, and such service shall to all purposes be deemed a sufficient service of such notice or document on all Persons interested (whether jointly with or as claiming through or under him) in the Share
- Notice of every Shareholders meeting shall be given to
 - (a) all Shareholders holding Shares with the right to receive notice and who have supplied to the Company an address for the giving of notices to them, and
 - (b) every Person entitled to a Sharehun consequence of the death or bankruptcy of a Shareholder, who but for his death or bankruptcy would be entitled to receive notice of the meeting

No other Person shall be entitled to receive notices of Shareholders' meetings

INDEMNITY

- Subject to the limitations hereinafter provided the Company may indemnify against all expenses, including legal fees, and against all judgments, fines and amounts paid in settlement and reasonably incurred in connection with legal, administrative or investigative proceedings any Person (an "Indemnifiable Person") who
 - (a) is or was a party or is threatened to be made a party to any threatened, pending or completed proceedings, whether civil, criminal, administrative or investigative, by reason of the fact that the Person is or was a Director, an Officer, agent or a liquidator of the Company, or
 - (b) is or was, at the request of the Company, serving as a director, officer, agent or liquidator of, or in any other capacity is or was acting for, another body corporate or a partnership, joint venture, trust or other enterprise

- The termination of any proceedings by any judgment, order, settlement, conviction or the entering of a *nolle prosequi* does not, by itself, create a presumption that the Indemnifiable Person did not act honestly and in good faith and with a view to the best interests of the Company or that such Person had reasonable cause to believe that his conduct was unlawful.
- Expenses, including legal fees, incurred by an Indemnifiable Person in defending any legal, administrative or investigative proceedings may be paid by the Company in advance of the final disposition of such proceedings upon receipt of an undertaking by or on behalf of the Indemnifiable Person to repay the amount if it shall ultimately be determined that the Indemnifiable Person is not entitled to be:indemnified by the Company in accordance with these Articles

 Expenses, including legal fees incurred by a former Director. Officer or agent in defending any legal, administrative or investigative proceedings may be paid by the Company in advance of the final disposition of such proceedings upon receipts of an undertaking by or on behalf of the former Director. Officer or agent, as the case may be lio repay the amount if it shall ultimately be determined that the former Director. Officer or agent is inportantly to be indemnified by the Company in accordance with these Articles and upon such other terms and conditions, if any, as the Company deems appropriate
- The indemnification and advancement of expenses provided by, or granted pursuant to, this section is not exclusive of any other rights to which the Person seeking indemnification or advancement of expenses may be entitled under any agreement, resolution of members, resolution of disinterested Directors or otherwise, both as to acting in the Person's official capacity and as to acting in another capacity while serving as a Director, if applicable
- 150 If a Person to be indemnified has been successful in defence of any proceedings described above the Person is entitled to be indemnified against all expenses, including legal fees, and against all judgments, fines and amounts paid in settlement and reasonably incurred by the Person in connection with the proceedings

INSURANCE

151. The Company may purchase and maintain insurance in relation to any person who is or was a Director, or who at the request of the Company is or was serving as a Director of, or in any other capacity is or was acting for another body corporate or a partnership, joint venture, trust or other enterprise, against any liability asserted against the person and incurred by the person in that capacity, whether or not the Company has or would have had the power to indemnify the person against the liability in the preceding Article

NON-RECOGNITION OF TRUSTS

Subject to the proviso hereto, no Person shall be recognised by the Company as holding any Share upon any trust and the Company shall not, unless required by law, be bound by or be

compelled in any way to recognise (even when having notice thereof) any equitable, contingent, future or partial interest in any Share or (except only as otherwise provided by these Articles or as required by law) any other right in respect of any Share except an absolute right to the entirety thereof in each Shareholder registered in the Register of Members, provided that, notwithstanding the foregoing, the Company shall be entitled to recognise any such interests as shall be determined by the Directors

VOLUNTARY LIQUIDATION

- The Company may voluntarily commence its liquidation and dissolution by appointing a voluntary 153 liquidator in accordance with section 199 of the Act if
 - it has no liabilities, or (a)
 - it is able to pay its debts as they fall due and the value of its assets equals or exceeds its (b) liabilities

DISCLOSURE

The Directors, or any service providers (including the Officers, the Secretary and the Registered Agent of the Company) specifically authorised by the Directors, shall be entitled to disclose to any regulatory or judicial authority any information regarding the affairs of the Company including without limitation information contained in the Register of Members and books of the Company
