Extract from the Limited Liability Company Agreement of RBP Finance LLC

Article III

3 1 Board of Members

3 1 1 The Business of the Company shall be managed solely by or under the direction of the Board of Managers who may exercise all the powers of the Company except as otherwise provided by law or by this agreement (the Board).
