Extract from the Limited Liability Company Agreement of RBP Finance LLC

Article III

3 1 Board of Members

3 1 1 The Business of the Company shall be managed solely by or under the direction of the Board of Managers who may exercise all the powers of the Company except as otherwise provided by law or by this agreement (the Board). No individual member of the Board (each a Manager) shall be considered a "Manager" of the Company as such term is defined under the Act or have any individual authority in respect of the management of the Company whatsoever except as previously granted by the Board.
