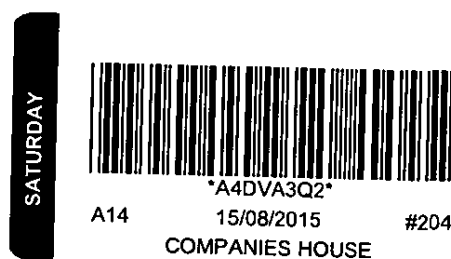



At the Balance Sheet date the company owed its parent company (Doyle Sails New Zealand Limited) £1,000 by way of a zero interest inter-company loan


For the year ending 31 March 2015 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies
