NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2016 AND 2015

1. ORGANIZATION AND SIGNIFICANT ACCOUNTING POLICIES

Nature of operations – The Specialty Coffee Association of America (the Association) was incorporated on December 27, 1991 as a nonprofit national trade association and is headquartered in Santa Ana, California.

The purpose of the Association is to promote nationwide public interest regarding coffee and coffee beverages of the highest quality, provide education about cultivation, processing, preparation, and marketing of specialty coffee, establish a common forum for discussion among industry members, ensure a sense of industry purpose and cooperation, and to enhance the unified character of the industry.

Basis of accounting and financial statement presentation — The financial statements are prepared on the accrual basis of accounting and in conformity with professional standards applicable to not-for-profit entities.

Revenue recognition – Membership dues are recognized based on the subscription year to which the dues relate. Exposition and events revenue are recognized in the fiscal year in which the related event occurs. Education training program and event fees are recognized in the fiscal year in which the training occurs. Resource center sales are recognized when the inventory is shipped to the customer. Directory publication revenue is recognized in the fiscal year in which the directory is published.

Functional expenses – The costs of providing various program services have been summarized on a functional basis in the statements of activities and of functional expenses. Accordingly, certain costs have been allocated among the program services based on employee's time incurred and management's estimate of the usage of resources.

Cash and cash equivalents – For financial statement purposes, the Association considers all investments with an initial maturity of three months or less to be cash equivalents.

The Association minimizes credit risk associated with cash by periodically evaluating the credit quality of their primary financial institution. The balance at times may exceed federally insured limits. The Association has not experienced any losses in such accounts and management believes the Association is not exposed to any significant credit risk related to cash.

Accounts receivable – Accounts receivable are stated at the amount management expects to collect from outstanding balances. Management has estimated an allowance for doubtful accounts based on historical performance. As of September 30, 2016 and 2015, an allowance for doubtful accounts was recorded at \$4,382 and \$6,752, respectively.

Inventory – Inventory consists of educational materials and promotional items related to the specialty coffee industry. Inventory is stated at the lower of cost or market value on an average cost basis.

NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2016 AND 2015

Intangible assets represent the capitalized costs to develop consumer reports, which are available as digital downloads for sale to customers and an internally developed market survey. These assets are amortized over their estimated useful lives of three years. Accumulated amortization totaled \$56,572 and \$33,281 as of September 30, 2016 and 2015, respectively.

Property and equipment is stated at cost. The Association capitalizes all expenditures of property and equipment in excess of \$500. Depreciation is computed using the straight-line method over estimated useful lives of individual assets ranging from 3 to 10 years.

Deferred rent – The Association records rent expense on a straight-line basis, and the deferred rent liability pertaining to free rent and future rent increases has been accrued.

Income taxes – The Association is exempt from income taxes under Section 501(c)(6) of the Internal Revenue Code. The Association has applied the accounting principles related to accounting for uncertainty in income taxes and has determined that there is no material impact on the financial statements. With some exceptions, the Association is no longer subject to U.S. federal and state income tax examinations by tax authorities for years prior to 2012.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent events have been reviewed through January 26, 2017, the date the financial statements were available to be issued. Management concluded that no material subsequent events have occurred since September 30, 2016 that require recognition or disclosure in the financial statements.

Reclassifications – Certain 2015 amounts have been reclassified to conform with the 2016 financial statement presentation.

5. NOTE PAYABLE

Related to the lease described above, the Association entered into a note payable agreement with their lessor to finance leasehold improvements. The note bears interest at a rate of 3.5% per annum with monthly payments, including accrued interest, of \$689, and matures August 2019. 6. SIMPLIFIED EMPLOYEE PENSION PLAN

The Association has a defined contribution Simplified Employee Pension Plan (SEP) covering all employees with at least one year of service. Contributions to the plan are at the Association's discretion. During the fiscal years ended September 30, 2016 and 2015, the Association elected to fund the SEP \$106,411 and \$71,959, respectively. Unpaid contributions to the plan are included in accrued liabilities.

7. RELATED PARTY TRANSACTIONS

The Association sponsored the creation of the Coffee Quality Institute (the Institute) in 1996. The Institute provides research and education for the improvement of the quality of coffee and is endorsed by the Association. However, the Institute is not under the control of the Association, and therefore, the financial statements do not include the accounts of the Institute.

During 2015, the Institute shared facility space with the Association and the Institute was invoiced \$14,375 by the Association for its share of the facility expenses and supplies. The Association was billed \$17,041 and \$32,845 by the Institute for contracted services and support, supplies, and event sponsorships during fiscal years 2016 and 2015, respectively. These billings were applied against the Institute's accounts receivable balance owed to the Association. As of September 30, 2016 and 2015, the Institute owed the Association \$164,634 and \$132,100, respectively.

The Association and Speciality Coffee Association of Europe (SCAE) are each 50% owners of World Coffee Events Limited (WCE), an events management company for the specialty coffee community worldwide. The Association's Executive Director serves as a non-voting member on WCE's Board of Directors. The Association accounts for its ownership in WCE under the equity method. Because the financial statements of WCE reflect a net deficit balance at September 30, 2016 and 2015, the Association's initial investment in WCE of \$13 has been reduced to zero as of September 30, 2016 and 2015. During 2016 and 2015, the Association earned management fee revenue of \$30,267 and \$37,500, respectively, from WCE. As of September 30, 2016 and 2015, WCE owed the Association \$192,196 and \$170,041, respectively.

8. SUBSEQUENT EVENT AND BUSINESS COMBINATION

During 2015, the Association committed resources to explore the potential combination of the Association and SCAE. The Association's Board and Management collectively believed that such a combination would allow for international growth, greater influence on policy, research alignment, and provide for a unified set of standards and definitions for the specialty industry. In January of 2016, the Association and SCAE agreed to move forward with the combination. In May of 2016, members of SCAE voted and approved an initiative to move towards unification. Subsequently, in August of 2016, members of the Association approved an initiative to move forward with the unification of the entities. Effective January 1, 2017, SCAE and the Association began to operate as a unified entity. The combined entity continues to work towards finalizing the legal and organizational process of the business combination.

Expenses of \$356,842 and \$115,312 were incurred during 2016 and 2015, respectively, to facilitate the unification. Such expenses consist primarily of professional services and travel costs.
