- i. FORTUNA Equity GmbH transferred 38.5% of its interest in the Partnership, including 38.5% of its capital contribution, to Pomona Capital IX, L.P.:
- ii. FORTUNA Equity GmbH transferred 38.5% of its interest in the Partnership, including 38.5% of its capital contribution, to Pomona Capital X, L.P.; and
- iii. FORTUNA Equity GmbH transferred 23% of its interest in the Partnership, including 23% of its capital contribution, to Pomona Investment Fund.

As a result of such transfers,:

- i. Pomona Capital IX, L.P. was admitted as a limited partner of the Partnership;
- ii. Pomona Capital X, L.P. was admitted as a limited partner of the Partnership;
- iii. Pomona Investment Fund was admitted as a limited partner of the Partnership; and
- iv. FORTUNA Equity GmbH ceased to be a limited partner of the Partnership.

g. The sum contributed by any limited partner

The following changes in sums contributed by limited partners have occurred:

- FORTUNA Equity GmbH transferred 38.5% of its interest in the Partnership, including 38.5% of its capital contribution amounting to EUR 192.5, to Pomona Capital IX, L.P.;
- ii. FORTUNA Equity GmbH transferred 38.5% of its interest in the Partnership, including 38.5% of its capital contribution amounting to EUR 192.5, to Pomona Capital X, L.P.; and
- iii. FORTUNA Equity GmbH transferred 23% of its interest in the Partnership, including 23% of its capital contribution amounting to EUR 115, to Pomona Investment Fund.

As a result of such transfers:

- Pomona Capital IX, L.P. was admitted as a limited partner of the Partnership and held a capital contribution of EUR 192.5;
- Pomona Capital X, L.P. was admitted as a limited partner of the Partnership and held a capital contribution of EUR 192.5; and
- iii. Pomona Investment Fund was admitted as a limited partner of the Partnership and held a capital contribution of EUR 115.
