## c. Change in partners or the name of any partner

The following changes in the limited partners of the Partnership have occurred:

- ii. ASSURANCES DU CREDIT MUTUEL VIE SA SFGE transferred 27.43% of its interest in the Partnership, including 27.43% of its capital contribution, to ODDO BHF ASSET MANAGEMENT S.A.S. on behalf of ODDO BHF Debt & Equity Opportunities FCPR. As a result of such transfer ODDO BHF ASSET MANAGEMENT S.A.S. on behalf of ODDO BHF Debt & Equity Opportunities FCPR was admitted as a limited partner of the Partnership and ASSURANCES DU CREDIT MUTUEL VIE SA SFGE ceased to be a limited partner of the Partnership.
- iii. ASSURANCES DU CREDIT MUTUEL VIE SA SFGE transferred 18.80% of its interest in the Partnership, including 18.80% of its capital contribution, to ODDO BHF ASSET MANAGEMENT S.A.S. on behalf of ODDO BHF GLOBAL SECONDARY FCPR. As a result of such transfer ODDO BHF ASSET MANAGEMENT S.A.S. on behalf of ODDO BHF GLOBAL SECONDARY FCPR was admitted as a limited partner of the Partnership and ASSURANCES DU CREDIT MUTUEL VIE SA SFGE ceased to be a limited partner of the Partnership.
- iv. ASSURANCES DU CREDIT MUTUEL VIE SA SFGE transferred 31.37% of its interest in the Partnership, including 31.37% of its capital contribution, to ODDO BHF SECONDARIES FUND II SLP. As a result of such transfer ODDO BHF SECONDARIES FUND II SLP was admitted as a limited partner of the Partnership and ASSURANCES DU CREDIT MUTUEL VIE SA SFGE ceased to be a limited partner of the Partnership.

As a result of such transfers, ODDO BHF Asset Management S.A.S. on behalf of CAA Secondaire V FPCI, ODDO BHF ASSET MANAGEMENT S.A.S. on behalf of ODDO BHF Debt & Equity Opportunities FCPR, ODDO BHF ASSET MANAGEMENT S.A.S. on behalf of ODDO BHF GLOBAL SECONDARY FCPR, & ODDO BHF SECONDARIES FUND II SLP were each admitted as a limited partner of the Partnership.

As a result of such transfer to ODDO BHF ASSET MANAGEMENT S.A.S. on behalf of ODDO BHF Debt & Equity Opportunities FCPR was admitted as a limited partner of the Partnership and held a capital contribution of EUR 89.16 and ASSURANCES DU CREDIT MUTUEL VIE SA SFGE ceased to be a limited partner of the Partnership.
- iii. ASSURANCES DU CREDIT MUTUEL VIE SA SFGE transferred 18.80% of its interest in the Partnership, including 18.80% of its capital contribution amounting to EUR 61.10 to ODDO BHF ASSET MANAGEMENT S.A.S. on behalf of ODDO BHF GLOBAL SECONDARY FCPR. As a result of such transfer to ODDO BHF ASSET MANAGEMENT S.A.S. on behalf of ODDO BHF GLOBAL SECONDARY FCPR was admitted as a limited partner of the Partnership and held a capital contribution of EUR 61.10 and ASSURANCES DU CREDIT MUTUEL VIE SA SFGE ceased to be a limited partner of the Partnership.
- iv. ASSURANCES DU CREDIT MUTUEL VIE SA SFGE transferred 31.37% of its interest in the Partnership, including 31.37% of its capital contribution amounting to EUR 101.94 to ODDO BHF SECONDARIES

FUND II SLP. As a result of such transfer to ODDO BHF SECONDARIES FUND II SLP was admitted as a limited partner of the Partnership and held a capital contribution of 101.94 and ASSURANCES DU CREDIT MUTUEL VIE SA SFGE ceased to be a limited partner of the Partnership.
