### Extract from Articles of Association of the Church Mission Society Ireland

#### **Article No 41 (a).**

The Trustees may meet together for the dispatch of business, adjourn and, otherwise regulate their meetings as they think fit. Questions arising at any meeting shall, be decided by a majority of votes. Where there is an equality of votes, the Chairperson shall have a second or casting vote. A Trustee may, and the secretary, on the requisition of a Trustee shall, at any time summon a meeting of the Board of Trustees. If the Board of Trustees so resolve it shall not be necessary to give notice of a meeting of the Board of Trustees to any Trustee who being resident in the Republic of Ireland is for the time being absent from the Republic of Ireland.

#### **Article No 43**

The quorum necessary for the transaction of the business of the Board of Trustees shall be five (with at least one Trustee from Northern Ireland and one Trustee from the Republic of Ireland being present).
