Article No. 41. (a) The Trustees may meet together for the dispatch of business, adjourn and, otherwise regulate their meetings as they think fit. If the Board of Trustees so resolve it shall not be necessary to give notice of a meeting of the Board of Trustees to any Trustee who being resident in the Republic of Ireland is for the time being absent from the Republic of Ireland.

Article No. 43

The quorum necessary for the transaction of the business of the Board of Trustees shall be five (with at least one Trustee from Northern Ireland and one Trustee from the Republic of Ireland being present).
