

1. INTRODUCTION

The Company's proposals for a Voluntary Arrangement were approved by creditors at a meeting of creditors held on the 8 July 2021.

This is my final report regarding the implementation of the Company Voluntary Arrangement ("CVA" or "Voluntary Arrangement").

2. BACKGROUND

I, Rachel Fowler, was appointed Supervisor of the Voluntary Arrangement on the 8 July 2021.

The Company's financial pressures have mounted over the last number of years. It is operated by volunteers and relies on the goodwill and support of a vast number of people to survive. It has benefited from this in the past, however the cash pressures and volatility of the finances have left it unmanageable.

3. ASSET REALISATIONS

Cash at Bank

The Company had a Bank account with Ulster Bank, £5,734 was transferred to the Supervisor prior to the CVA being approved.

Debtors

On approval of the CVA, and strictly subject to the terms of the Tourism Northern Ireland Letter of Offer dated 3rd July 2019 (the "Letter of Offer") and Addendum thereto, Tourism Northern Ireland released a TNI Grant of £60,000 into a separately designated account held on trust by the Supervisor for the purposes of the proposal.

There were further debtors totalling £1,200. After making attempts to collect the balances, it was deemed not commercial to pursue further. This decision was taken with consent of the Supervisor and did not contravene the terms of the CVA proposal.

4. CREDITORS' CLAIMS

Preferential

No preferential claims were anticipated or received in this matter.

Unsecured non-preferential

Unsecured creditors, as per the statement of affairs were estimated at £311,183.47. Claims totalling £252,935.56 have been received.

5. DIVIDENDS

The projected level of dividend in the Proposal was 15 pence in the pound. Total dividends to unsecured creditors were 16.87 pence in the pound. In total £44,266.50 was distributed to 52 unsecured creditors on 27 January 2022.

6. COSTS AND EXPENSES

The payments shown on the summary of the receipts and payments at Appendix I are in the main self-explanatory. Should you have any queries, please contact Chris Donaghy at my Moira office.

The Company Accountant Lynn Drake & Co was paid £1,200 for ensuring the Company's financial compliance was brought up to date and all post CVA returns to HMRC were completed.

The time costs of Rachel Fowler Advisory Ltd are as analysed at Appendix II. I have drawn a Nominee fee of £10,000. To date, I have incurred £11,857.75 in time costs in relation to Supervisor fees of which I have drawn £11,231.50. The remaining balance, along with any future time costs will be written off.

7. CONCLUSION

I have completed my administration of this case and have issued a Certificate of Completion to the Company Directors. A copy of this is attached for your information. Please note, no further reports or correspondence will be issued.
