NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31ST MARCH 2003

1. ACCOUNTING POLICIES

1.1 BASIS OF ACCOUNTING

The financial statements have been prepared under the historical cost convention. The principal accounting policies which have been adopted within that convention are set out below.

1.2 TURNOVER

Turnover represents the total invoice value, excluding value added tax, of goods sold and services rendered including group companies during the year.

1.3 INVESTMENTS

Investments are usually stated at cost, but are written down to realisable value if there has been a permanent diminution in value.

1.4 STOCKS AND WORK IN PROGRESS

Work in progress is stated at the lower of cost and net realisable value. Bank interest incurred on borrowings used to finance specific developments is capitalised until the date work commences on the development. Thereafter, all interest incurred is expenses to the profit and loss account in the period it arises.

Undeveloped land is stated at cost, which comprises purchases price plus all associated legal and professional costs.

1.5 DEFERRED TAXATION

The company provides deferred taxation to take account of timing difference between the treatment of certain items for accounts purposes and their treatment for taxation purposes on a liability method execpt where a liability is not considered likely to arise in the foreseeable future.

1.6 LEASING AND HIRE PURCHASE

(a) Finance leases

Finance leases have been capitalised with the company's rights in such assets included in the balance sheet under tangible assets and the obligation to make future payments under these leases have been included under creditors

(b) Operating leases

Payments made under operating leases are charged to the profit and loss acount on a straight line basis.

(c) Hire Purchase contracts

Hire Purchase contracts are dealt with in a similar fashion to finance leases.
