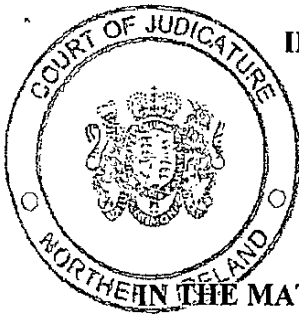

- 7) An Order that John Charles Reid be released from all liability pursuant to the relevant Articles of the Insolvency (Northern Ireland) Order 1989 in respect of his acts and omissions as Liquidator and Administrator, as applicable, in respect of each of the Companies listed in Appendices One and Two hereto such release to take effect in relation to each relevant estate 28 days after report to Creditors in all cases.
- 8) An Order that Peter Michael Allen be released from all liability pursuant to the relevant Articles of the Insolvency (Northern Ireland) Order 1989 in respect of his acts and omissions as Administrator in respect of each of the Companies listed in Appendix Three hereto such release to take effect in relation to each relevant estate 28 days after report to Creditors in all cases.
- 9) That there be no order as to costs.
