1. Accounting policies

Statement of compliance

Belfast Educational Services (Downpatrick) Holdings Limited is a private limited liability company incorporated in Northern Ireland. The Registered Office is The Soloist Building, I Lanyon Place, Belfast BTI 3LP.

The financial statements have been prepared in compliance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" as it applies to the financial statements of the company for the year ended 31 March 2023.

Basis of preparation

The financial statements are prepared on a going concern basis under the historical cost convention and in accordance with FRS 2 and the Companies Act 2006. The financial statements are prepared in Sterling which is the functional currency of the company.

The company has taken advantage of the following disclosure exemptions in preparing these financial statements, as permitted by FRS 102:

the requirements of section 7 Statement of Cash Flows.

The company has not presented group financial statements because it has taken advantage of the exemption available to small sized groups available under the Companies Act 2006. The company's financial statements present information about it as an individual undertaking and not about its group.

Investments in subsidiaries
