### 1. Accounting policies

### Statement of compliance

Belfast Educational Services (Down & Connor) Holdings Limited is a private limited liability company incorporated in Northern Ireland. The Registered Office is Cambane House, Shepherds Way, Newry, Co. Down, BT35 6EE.

The financial statements have been prepared in compliance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" as it applies to the financial statements of the company for the year ended 31 March 2022.

#### Basis of preparation

The financial statements are prepared on a going concern basis under the historical cost convention and in accordance with FRS 102 and the Companies Act 2006 The financial statements are prepared in Sterling which is the functional currency of the company.
