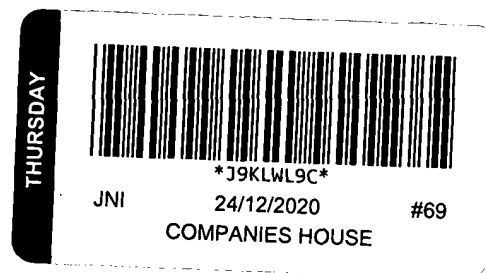


For the year ended 29 February 2020, the Company was entitled to exemption from audit under Section 480 of the Companies Act 2006 relating to dormant companies.
