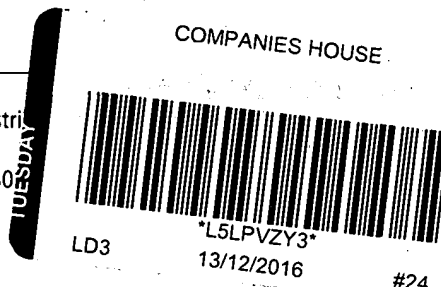

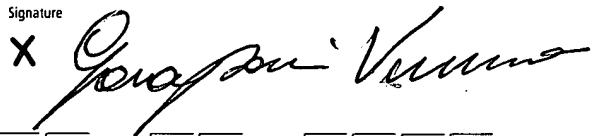
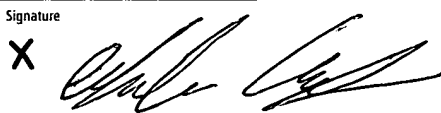

Notify all parties
