

Notice of the Joint Administrators' Proposals in absence of a Meeting of Creditors

Pursuant to Rule 2.46 Insolvency Rules 1986 I report as follows:

The Joint Administrators' proposals were deemed to be approved as follows;

- (a) Pending the outcome of the Administration, they be at liberty to discharge their functions in accordance with the first objective of the statutory purpose of the administration, and
- (b) they make payments to the secured creditor,
- (c) should the Partnership not be rescued,

- (i) the Partnership will be dissolved pursuant to Paragraph 84 of Schedule B1 of the Insolvency Act 1986, or

- (ii) if there are sufficient funds to enable a distribution to the unsecured creditors, the Administrators will exit the Administration via a Creditors' Voluntary Liquidation and Shay Bannon and Sarah Megan Rayment will be Joint Liquidators acting jointly and severally

NB. Under Paragraph 83(7) of Schedule B1 of the Insolvency Act 1986 and Rule 2.117, creditors may nominate different Liquidators, but in the absence of such nomination, the above named would become the Liquidators

- (d) if a meeting of creditors is requisitioned, creditors consider and if thought fit appoint a creditors' committee to assist the Joint Administrators (such committee must comprise of between 3 and 5 creditors)


In the absence of a creditors committee,

- (e) the Joint Administrators' remuneration be approved on a time costs basis which in the event of a payment in full to creditors will be subject to the approval of the members or if there is insufficient property to pay creditors in full it will be subject to creditor approval

A further resolution is put to the creditors.

- (f) that the Joint Administrators be discharged from liability under the Administration per Paragraph 98 of Schedule B1 of the Insolvency Act 1986, 28 days after the Joint Administrators' filing their final report and sending it to creditors
