UPON THE APPLICATION by a Claim Form dated the 6th August 2019 of Robert Philip Kanerick the Claimant and a person with a potential legal claim against the above named Evans Randall Europe LLP (hereinafter called "the LLP") pursuant to Section 1029(2)(f) of the Companies Act 2006

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the waiver letter from the Treasury Solicitor dated the 24th October 2019



AND the Claimant undertaking to:

- (A) inform the Registrar of Companies of the title and Court reference number of the proposed litigation seeking an Order under Section 1096(1) of the Companies Act 2006 rectifying the Register that documentation filed on the Register resigning the Claimant as a Designated Member of the LLP be removed from the LLP's public file as allegedly being either (i) invalid and/or (ii) ineffective and/or (iii) done without the authority of the LLP (iv) and/or factually inaccurate and/or (v) forged, as referred to in paragraph 33 (a) of the Witness Statement of Robert Philip Kanerick dated the 24 June 2020 and that the Claimant be deemed not to have been removed as a Designated Member or be reinstated as such immediately after issue.
- (B) inform the Registrar of Companies immediately on the conclusion of the said proposed litigation or any appeal therefrom.
- (C) if the application seeking an Order under Section 1096(1) of the Companies Act 2006 is successful, immediately make a further application to the Court within these restoration proceedings seeking to vary the restoration Order to reflect the further intended steps and serve such further application on the Registrar of Companies.

AND UPON the solicitors for the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED that:

- (1) the name of the above named Evans Randall Europe LLP be restored to the Register of Companies •
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the LLP is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the LLP to OC316775 LLP
- (3) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the LLP is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"
- (5) the hearing fixed for the 9 July 2020 be vacated
