IN THE MATTER OF THE COMPANIES ACT 2006

UPON THE APPLICATION by a claim form dated 16 January 2019 of the Commissioners for Her Majesty's Revenue and Customs (the Claimants) and a creditor of the above named ERG Wind Italy 15 Limited Liability Partnership (hereinafter called "the Partnership")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the waiver letter from the Treasury Solicitor dated 12 February 2019.

AND UPON the Claimants undertaking to:

- A) Inform the Registrar of Companies of the title and reference number of any Appeal made by the Partnership to the First Tier Tax Tribunal against any closure notice to the Partnership.
- B) Promptly inform the Registrar of Companies of the final determination (being the point at which no further appeal may be brought before any Court by either party) of such appeal.

AND UPON the Claimants and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- 1) The name of the above named ERG Wind Italy 15 Limited Liability Partnership be restored to the Register of Companies





- 2) If at the date of registration of this Order with the Registrar of Companies the name of the Partnership is not available, the Registrar of Companies shall, pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Partnership to OC317737 Limited Liability Partnership
- 3) An office copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Partnership is thereupon to be deemed to have continued in existence as if its name had not been struck off
- 4) The Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- 5) The Claimant do pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300.00

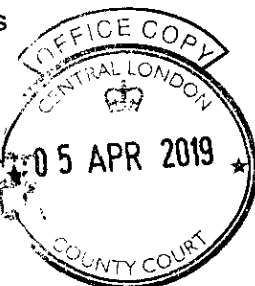



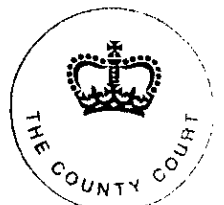
