ORDER

UPON THE APPLICATION of the Claimant by Part 8 Claim Form dated 9 December 2011 (the "Application")

AND UPON HEARING Counsel for the Claimants

AND UPON it appearing that the Respondent consents to the Application and the relief sought



AND UPON READING the evidence

AND UPON the Court being satisfied that the Forms MG02 and LL MG02 in Schedule 2 hereto (the "**Forms**") which were submitted to the Registrar of Companies recording the satisfaction and/or discharge of charges referred to in that Schedule (the "**Current Charges**") were submitted without authority

AND UPON the Court being further satisfied that the mis-statement by incorrect registration of the satisfaction and/or discharge of the Charges on the Register of Charges of each of the Claimants was due to inadvertence or was accidental and rectification of the Register will not prejudice creditors of the Claimants and it is just and equitable to grant relief

IT IS HEREBY DECLARED THAT:

- 1 The Forms listed in Schedule 2 hereto were delivered to the Registrar of Companies without the authority of the Claimants and the Forms contain material which is factually inaccurate in that they record erroneously that the Current Charges have been satisfied and/or discharged

AND IT IS ORDERED THAT:

1. the Claimants be granted permission pursuant to CPR 17.1 to amend the Claim Form by seeking the additional relief in respect of the Twenty-Seventh Claimant, Forty-Third Claimant and Sixty-Second Claimant set out in the draft Amended Claim Form supplied to the Court;
- 2 pursuant to section 873 Companies Act 2006 (the "**2006 Act**") (and in the case of the First to Eighteenth Claimants (inclusive) pursuant to section 873 of the 2006 Act, as applied by the Limited Liability Partnerships (Application of Companies Act 2006) Regulations 2009 (the "**LLP Regulations**")) the Register of Charges in respect of each of the Claimants be rectified by the deletion of any memoranda of satisfaction in respect of the Current Charges and any other particulars in the Register of Charges referring to the satisfaction and/or discharge of the Current Charges;



3. pursuant to section 1096 of the 2006 Act (and in the case of the First to Eighteenth Claimants (inclusive) pursuant to section 1096 of the 2006 Act, as applied by the LLP Regulations), that the Forms listed in Schedule 2 hereto be removed from the filing history of each of the Claimants and all references to such Forms be deleted from the records maintained by the Registrar of Companies,
- 4 the Claimants deliver an Office Copy of this Order to the Respondent within 21 days of the date of this Order, and
5. there be no order as to costs.
