PRINCIPAL ACTIVITY & REVIEW OF BUSINESS

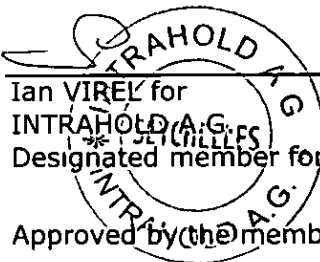
During the current financial period, the company was active as trade agent for construction materials and received commission.

RESPONSIBILITY

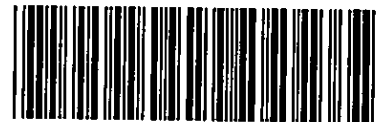

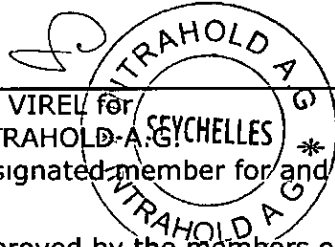
