During the current financial period, the company was active as trade agent for frozen food products and received commission.

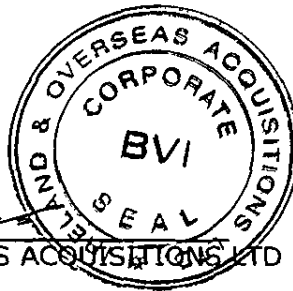
NOTE

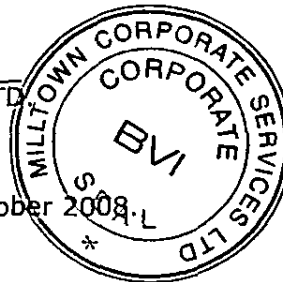
RESPONSIBILITY



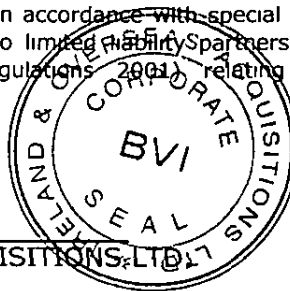

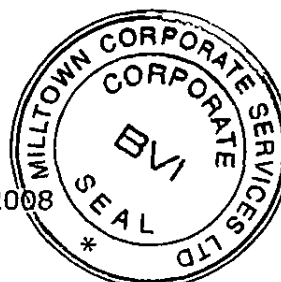
