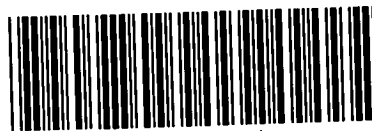


Chartered Accountant's Report to the Members on the Preparation of the Unaudited Statutory Financial Statements of Lavender Hill Colours LLP
