**PRINCIPAL ACTIVITY & REVIEW OF BUSINESS**

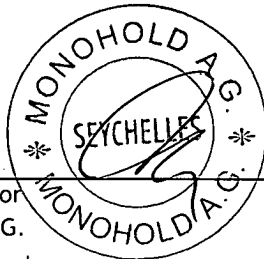
During the current financial period, the company was active as trade agent for building materials and received commission.

**RESPONSIBILITY**

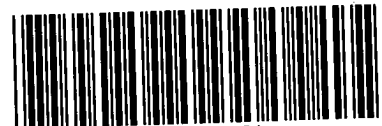

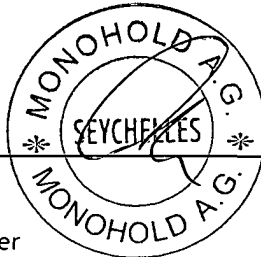

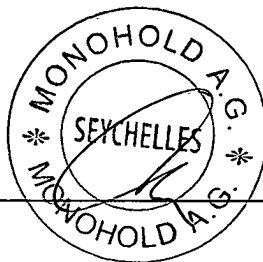
