NOTE



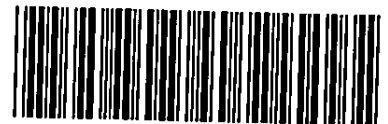
RESPONSIBILITY


