PRINCIPAL ACTIVITY & REVIEW OF BUSINESS

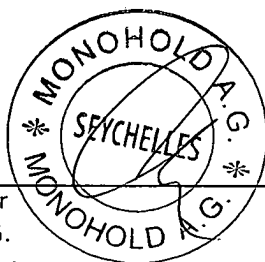
During the current financial period, the company was active as consultant for real estate projects and received commission.

RESPONSIBILITY

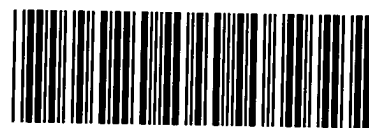

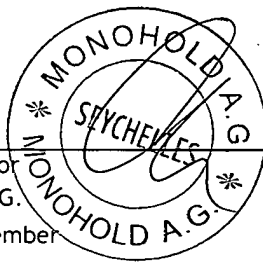
