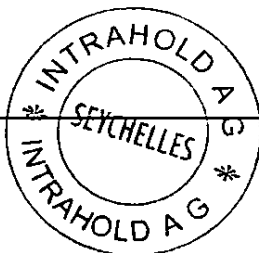
RESPONSIBILITY

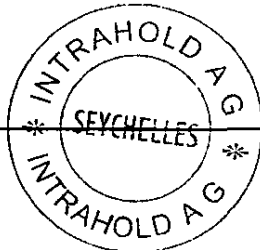


