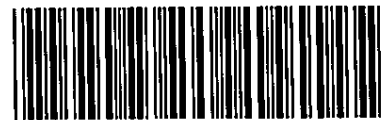

Accounting convention

Rentals paid under operating leases are charged to the profit and loss account on a straight line basis over the period of the lease
