During the current financial period the company was active as trade agent for industrial machines and received commission.

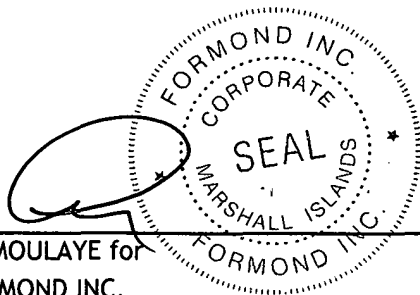
#### NOTE

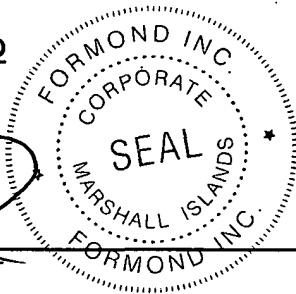

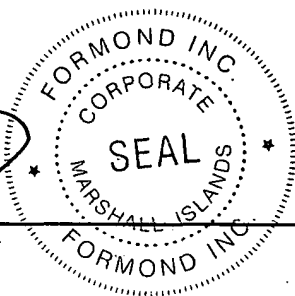
