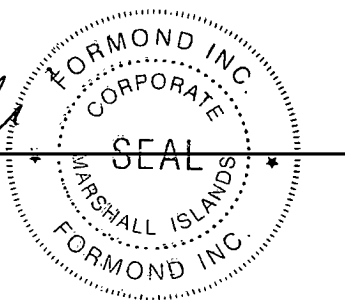
RESPONSIBILITY

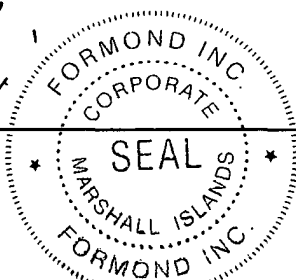
