PRINCIPAL ACTIVITY & REVIEW OF BUSINESS

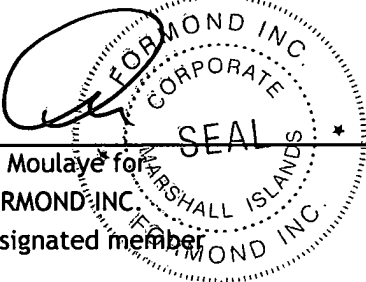
During the current financial period the company was active as commercial agent for building materials and received commission.

NOTE

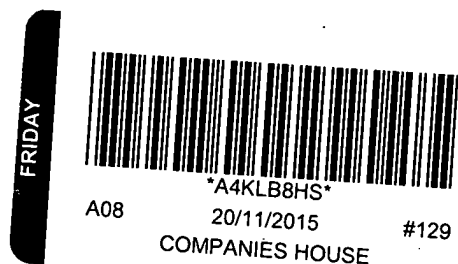

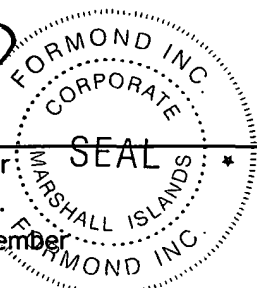

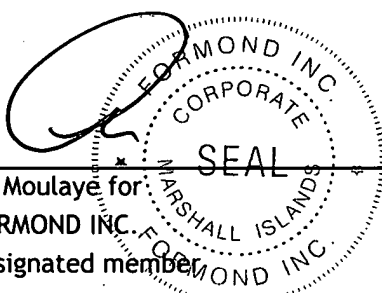
