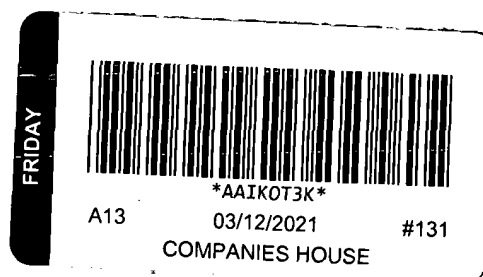

**PRINCIPAL ACTIVITY & REVIEW OF BUSINESS**


During the current financial period, the Partnership was active as trade agent for climate systems and received commission.
