During the current financial period the company was active as trade agent for commodities in Central Asia and received commission.


NOTE

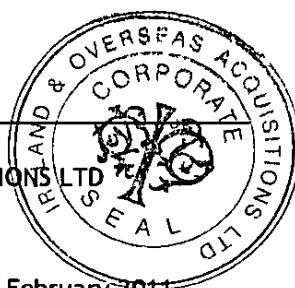



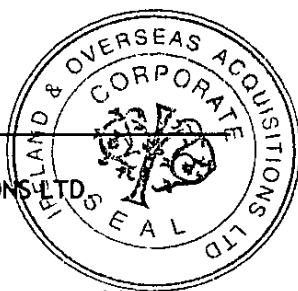
